### Importance, Challenges and Scope

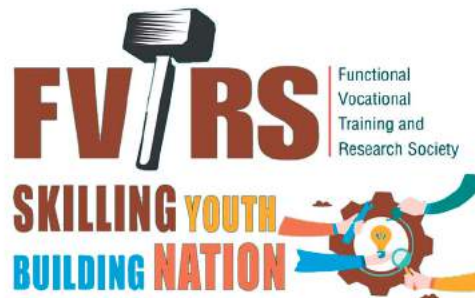

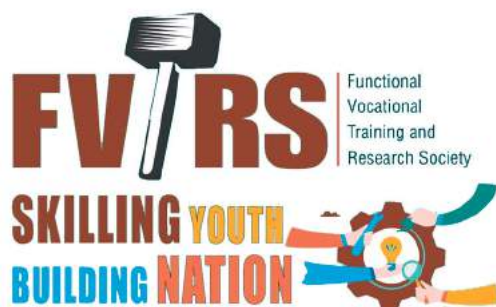
