### The EU Partners' Meeting: A Brief Report

The European Union had organized a meeting on 22 December, 2009 for its new partners on the occasion of the National Skill Conference held at Bangalore. 18 participants including the EU officials from Delhi took part.

Ms. Ellen Pedersen, Development Cooperation, Delegation to the European Union, India spoke on the following objectives in her introduction:

- Make the partners aware of each other in terms of their work and their presence in the VET sector in India under EU, VET programme through civil society
- Familiarise with EU commitment for new projects, the scale of operation and the potential impact that would result out of this commitment, from early 2010 over the next 5 years.
- Discuss points of synergy and start a platform of discussion amongst all on skills development.

She emphasized on the importance of working collectively as a group which will contribute to discussions at a professional level and provide input at macro level as well at National Policies.

Mr. R.M.P. Jawahar from Tiruchirappalli Regional Engineering College Science and Technology Entrepreneurs Park (TREC-STEP) made a presentation on "Building True Market Competencies". Ms. Nivedita Varshneya from Deutsche Welthungerhilfe did a presentation on "Skill sectors in rural settings generating meaningful employment and access to quality training for the disadvantaged communities". It was followed by a presentation on "Strengthening local economy and avenues for entrepreneurship development through Vocational Education Training" by Mr. Dibyendu Chaudhuri of PRADAN. Dr. Nalini Gangadharan from CAP Foundation made a presentation on "Institutional arrangements for quality assurance and certification".

Three groups were formed thereafter to discuss on the following issues:

- Addressing the issue of multi-sector collaboration – linkage and working arrangements between state, non-state and private sector in VET.
- Identification of areas of needs for collaboration within EU contracts
- Future plan of action for collaboration

The following action plans were prepared by the participants after group presentations:

- Mapping of Projects sector wise, geographical area wise, strengths and expertise.
- 2. Formation of e-Group consisting of EU partners in VET to provide a platform of continuous communication and sharing.
- 3. Sharing of Training Calendar/Workshop/ ToTs/Events by all partners on a continuous basis.
- 4. Meeting with Director of IGNOU on discussing possibilities of submitting joint proposal of interested organisations (among EU partners) on a GoI programme
- 5. Inclusion of EU's specific priorities in the curriculum.
- 6. Standardization of publications.
